- Random security and compliance audits conducted on player accounts.

Accepted Forms of Proof of Income

When submitting documents, clarity is key. WinSpirit's security team will typically accept several forms of verification. The most commonly requested documents are listed in the table below.

Document Type	Purpose & Notes
Recent Bank Statement (3 months)	Shows income deposits and overall cash flow. Ensure all pages are included and personal details are visible.
Payslips	Typically your last 2-3 payslips to confirm regular employment income.
Tax Return Assessment	An official document from your tax authority providing a high-level overview of annual income.
Official Letter from Employer	Should be on company letterhead, stating your position and salary.

The Submission Process and What to Expect



You will receive a direct request via email from WinSpirit's support or compliance team with precise instructions. The process usually involves uploading scanned copies or clear photos of your documents directly to a secure section of your account or via a secure email link. Once submitted, the standard verification time can range from 24 to 72 hours. During this period, your account may be temporarily limited from withdrawing or sometimes depositing until verification is complete.

Troubleshooting Common Delays and Issues

Delays most often occur due to incorrect document submission. Ensure your files are in an accepted format like JPG or PDF, that the images are clear and all corners of the document are visible, and that any sensitive information not related to the request (e.g., other bank transactions) is not obscured. If your verification is rejected, the team should provide a reason. If you run into issues, contacting support politely for clarification is the best course of action.
